

## Great North Run 2024 (Event) Terms and Conditions

### Fundraising Agreement:

I agree that I will;

1. Accept these Terms and Conditions and secure my place by payment of the non-refundable Registration Fee. By accepting the T&Cs you are agreeing to aim to raise £295.00 (in addition to the Registration Fee). This is a very important fundraiser for Hospice at Home Carlisle and North Lakeland and we need to make this event meaningful by raising as much money as possible to enable the charity to care for local patients, their families and carers.
2. Be aware that monies claimed from HMRC under the Gift Aid scheme do not count towards my fundraising total.
3. Pay all funds raised in the name of Hospice at Home to Hospice at Home Carlisle and North Lakeland within 30 days following the Event.
4. Keep details of the names and addresses of and amounts donated or pledged by all donors, and provide such details to Hospice at Home Carlisle and North Lakeland, on request.
5. Send details of how the money was raised, including all sponsorship forms when requested
6. Ensure that all cheques and other forms of donation are made payable to Hospice at Home Carlisle and North Lakeland.
7. Not raise funds by carrying out house to house collections.
8. Not collect in any public place without first obtaining a collector's licence from the local authority.
9. Not collect on private property (including shops, pubs etc) without first obtaining the permission of the owner.
10. Not organise any raffle or lottery without first contacting Hospice at Home Carlisle and North Lakeland and seeking approval for all promotional materials and tickets etc, used.
11. Advise the organisers in advance of organising any public events.
12. Not reproduce any of the Charity or Great North Run logos.
13. Not do anything to bring Hospice at Home Carlisle and North Lakeland into disrepute

### Terms and Conditions

1. You must be at least 17 years old on the date of the Event in order to take part.
2. To secure a place (subject to availability) you must pay a £65.00 non-refundable registration fee. Hospice at Home will send you confirmation if your application has been successful.
3. If at any point you feel that you are unable to raise the pledged amount you should inform the Fundraising Team at Hospice at Home immediately so that we can offer assistance with your fundraising.

4. All additional costs related to the Event including, but not limited to, travel and accommodation are the participant's responsibility.
5. Should you have to withdraw from the Event for any reason (including but not restricted to injury or illness) you must inform Hospice at Home immediately. When your withdrawal is acknowledged you will not be liable to raise any further sponsorship. Sponsorship funds already paid to Hospice at Home are refundable (excluding the Registration Fee) and any sponsorship funds held by you at the date of withdrawal must be returned to the donors or donated to Hospice at Home with the donors' permission.
6. Withdrawal from the Event will not be granted under any circumstances after the deadline for token redemption has passed (normally early July). If you are unable to run after this date, you will be required to pay the sponsorship pledge in full, or defer your place to next year's event.
7. Any deferred places must pay the Registration Fee again directly to event organisers 'the Great Run Company' to participate the following year. Tokens will then be distributed later the following year. Deferred places are those who are unable to partake in the Great North Run that year for whatever reason and choose to partake the following year.
8. All deferred places will be asked to pledge to raise £295.00 the following year.
9. Hospice at Home will not be liable for the safety and wellbeing of any participant and should you choose to participate in the Event you do so at your own risk. By accepting these Terms you accept full and complete responsibility and liability for your own health and accept that it is your responsibility to achieve the standard of physical fitness reasonably required in order to cover the distance required by the Event.
10. It is your responsibility to consult your doctor if you have any concerns about your ability to complete the Event safely and to monitor your own physical condition during the Event.
11. You should ensure that you wear appropriate clothing and footwear for the Event particularly if the Event takes place in inclement weather.
12. You agree that Hospice at Home can use any photograph(s) taken of you at the event in any literature, publicity, information material or publication promoting the charity's work. This may include brochures, posters, leaflets, display boards, website and any other appropriate materials.
13. You agree that Hospice at Home will share your details with the Great Run Company for event logistic purposes.
